The applicant(s) agrees that, if the request for service is granted, the following terms and conditions shall govern the relationship between PUD No. 2 of Pacific County and the applicant(s), their heirs, successors, and assigns.

The applicant(s), their heirs, successors, and assigns shall:

1. Comply fully with all existing and hereafter adopted or amended water system policies. For the purpose of this application, policies are defined as resolutions, ordinances, standards, guidelines and standard operating practices.
2. Pay any and all fees and charges in accordance with PUD No. 2 of Pacific County fee policies, both existing and hereafter adopted or amended.
3. Use the water for intended beneficial purposes and not run water inefficiently. Primary beneficial uses are human consumption, bathing, cleaning and watering of plants and lawn. The customer shall conserve water to the best of their ability and comply with the Lebam Water System Water Conservation Plan, which contains provisions for mandatory water conservation and curtailment by the customer as needed in case of drought and/or emergencies.
4. Acknowledge that service may be terminated for non-compliance with water system policies and non-payment of fees and charges.
5. Acceptance of this application by PUD No. 2 of Pacific County constitutes an expressed consent of water availability so long as PUD No. 2 of Pacific County has adequate capacity to serve the intended use. When capacity is limited by physical water system constraints or by acts of local, state or federal government, capacity shall be allocated on a priority basis in the order in which payment in full of the fees and charges are received by PUD No. 2 of Pacific County. However, acceptance of this application does not constitute a guarantee that adequate capacity is or will be available upon or after payment of the fees and charges.
6. The following facilities are either currently located or are proposed for the property to be served:

If items 1, 2 or 3 are present, the applicant will either Abandon the facilities or Install an approved backflow prevention device in accordance with PUD No. 2 policies. Service will not be activated until the above facilities are abandoned or a proper backflow prevention device is installed.
